#### Society News

The minutes of the 71<sup>st</sup> General Meeting in Montreal will be available on the Society website. Below are some particular highlights:

- The 71<sup>st</sup> General Meeting of the Society took place in Montreal, the second time this city had hosted the Society. There were 254 registered participants. The Society is grateful to Prof. Gerbern Oegema and his colleagues in Montreal for collaborating to ensure the success of the meeting. A full report of the academic programme of the General Meeting will be published in the April issue of *New Testament Studies.*
- Prof. Carl Holladay (USA) was inducted as *President* of the Society and delivered his Presidential Address, entitled 'Acts as Kerygma: λαλεῖν τὸν λὀγον'. He will be the Society's President until the next General Meeting in Pretoria.
- Prof. Michael Wolter (Germany) was elected *President* by the Society for the 2017 General Meeting in Pretoria, South Africa. He now serves on the Committee as *President-Elect*.
- Prof. Jean Zumstein (Switzerland) was nominated by the Committee to become *President* of the Society at the 2018 General Meeting in Athens, Greece.
- Main papers were delivered by Guy Bonneau (Canada), 'Images et émotions: Prolégomènes à l'étude de la réception des textes néotestamentaires dans les tableaux du



Caravage'; Paula Fredriksen (Israel), 'How Jewish is God? Theology and Ethnicity in Ancient Christianity'; Jens Herzer (Germany), 'Zwischen Mythos und Wahrheit: Neue Perspektiven auf die Pastoralbriefe'; and Risto Uro (Finland), 'Cognitive Science in the Study of Early Christianity: How it is helpful, and why?'

- The Quaestiones Disputatae, chaired by the President, engaged three panellists – Matthias Klinghardt (Germany); Jason BeDuhn (USA); Judith Lieu (UK) – who addressed the question 'Marcion's Gospel and the New Testament: Catalyst or Consequence?'
- Profs Andreas Dettwiler (Switzerland) and Christos Karakolis (Greece) retired from the Committee; and, Profs Uta Poplutz (Germany) and Risto Uro (Finland) were elected to replace them and serve as Trustees on the Committee for a period of three years.

- The *Treasurer*, Dr Kathy Ehrensperger (UK), indicated that the Society has had an income deficit over each of the past five years. President Lieu addressed both the need for and rationale behind the Committee's recommendation of an increase in annual subscription fees to address this income shortfall. The Society approved this proposal.
- The Assistant Secretary for International Initiatives, Prof. William Loader (Australia), reported on the work of the four Liaison Committees (Eastern European; African; Asia/ Pacific; Latin America/Caribbean). His full report will be available on the Society's website, and a summary will be included in the minutes of the 71<sup>st</sup> General Meeting. The Society's international initiatives include promoting New Testament scholarship in areas

beyond those where such research has traditionally been well represented within the Society, and to identify potential new members. Sponsorships enabled four members (from Jamaica, India, Kenya and Nigeria) and 10 guests (from Brazil, Chile, Colombia, Guatemala, Mexico, South Africa, and Italy) to attend the Montreal General Meeting.

- The Editor of New Testament Studies, Prof. Francis Watson (UK), reported that 118 articles had been submitted to the Journal over the past year. Nineteen had been accepted for publication. This represents an acceptance rate of about 16%. Bert Harrill, David Horrell, Antti Marjanen, Heike Omerzu, Tommy Wasserman, and Florian Wilk are due to retire from the Board at the end of 2016. To replace these members, the Editorial Board nominated (and the Society duly elected) the following members to serve in their place for a period of five years: Peter Arzt-Grabner (Austria), Helen Bond (UK), Hugh Houghton (UK), James Kelhoffer (Sweden), Candida Moss (USA), and Joseph Verheyden (Belgium).
- The Editor of the Monograph Series, Prof. Paul Trebilco (New Zealand), noted that two monographs had been published since the previous General Meeting, two further volumes were in production, and three titles had been placed under contract. More details will be available in the minutes of the 71<sup>st</sup> General Meeting. It was noted that Prof. Paul Trebilco will retire as Editor of the Monograph Series at the end of 2017. The Editorial Board nominated (and the Society, for its part, duly elected) Prof. Edward Adams (UK) to serve as his successor from 1<sup>st</sup> January 2018, for a period of 5 years.

The document 'Nominations for Membership (2017)' outlines the criteria for membership and the procedure that is used, and is available on the Society website. All nominations of new members must be received by 1<sup>st</sup> March.

## Pretoria 2017 – Preliminary Info

The Society will meet next year in Pretoria, South Africa, from Tuesday, 8<sup>th</sup> August, to Friday, 11<sup>th</sup> August, with optional excursions on both Saturday and Sunday, 12-13<sup>th</sup> August. I have just returned from visiting the venue – Pretoria 2017 promises to be a rich, academic and cultural experience.

Provisional information is already available at snts2017.org, including some details about practical arrangements (hotels, transportation, excursions, and the like). Online registration will be possible from March 2017. Additional details will be included in the February-March newsletter.

- Local Organising Committee: The Local Organising Committee is headed by Prof. Gert Steyn. Queries about the academic programme (main papers, offered short papers, seminar programs, and the like) may be addressed to the Secretary.
- Presidential Address and Main Papers: the Presidential Address will be given by Prof. Michael Wolter (Germany). Invited Main Papers will be given by Profs Matthias Konradt (Germany), Jean-Claude Loba Mkole (Kenya), Clare Rothschild (USA), and Josef Verheyden (Belgium).
- *Quaestiones Disputatae:* The topic of the session and the panellists are the responsibility of the *President-Elect,* Prof. Michael Wolter, in consultation with the current and *Past Presidents*.
- Seminars: there will be 15 seminars at the General Meeting in Pretoria (see the complete list later in the newsletter). The seminar programme will be finalized in February 2017, in time for the February-March newsletter. Conveners of seminars are reminded that the programme for 2017 has to be submitted to the Secretary by the 15<sup>th</sup> February, 2017 at the very latest. While it is normally the case that the conveners take the initiative in approaching members to present papers, members who would like to present a paper in one of the seminars should feel free to contact (one of) the conveners.
- Offered Short Papers: there will be 18 slots for Offered Short Papers. Members wishing to offer a short paper of 25 minutes should send a proposal to the Secretary. Proposals received before the 1<sup>st</sup> February will receive preference. The proposal should be accompanied by a onepage summary or outline in the chosen language. Papers may be offered in English, German, or French. New members especially

are encouraged to take advantage of this opportunity to present their research, but all members may, of course, do so. *Please note that members may as a rule deliver only one paper (of any kind) at a General Meeting.* 

- Nomination of Guests for the General Meeting in Pretoria: members wishing to nominate a scholar to be a guest at a General Meeting must submit the name to the Assistant Secretary, Prof. Todd Still. The invitation to attend the Society's General Meeting comes formally from the President, not from the member nominating the guest. No individual may be invited more than once in any four consecutive years; and, candidates for membership of the Society may not attend a General Meeting while they are being nominated for membership of the Society. Guests are of two kinds:
  - 1. Personal quests (as distinct from 'accompanying persons' such as partners or children). Any member attending a General Meeting may nominate a non-member to be invited to attend as her or his personal guest. This guest may participate fully in the academic programme, although not as a presenter. Members must indicate briefly to the Assistant Secretary how their guest would contribute to the proceedings. It is recommended that requests be submitted to the Assistant Secretary by the 1st April, although later requests may be considered if there is additional capacity. These quests will be asked to pay an additional sum of ca. €15 in lieu of Membership subscriptions.
  - 2. Seminar guests. Seminar conveners may nominate a non-member either to present a seminar paper or give a formal response to one. Only one quest is normally allowed to present a paper per seminar each year, which means that two of the three papers should as a rule be presented by members of the Society. Additional quests may, however, be nominated to give a formal response to one or more of the papers. Seminar leaders must indicate briefly the reasons for nominating the seminar guest to present or to respond to a paper. Requests to invite a seminar guest must be received by the Assistant Secretary no later than the 1<sup>st</sup> February, in order that the full Seminar

can be published in the February–March newsletter.

- Financial Support for Members and Guests at the Pretoria General Meeting: Members from the regions of the Society's international initiatives (Eastern Europe, Africa, Asia/Pacific, and Latin America/Caribbean) may be eligible for sponsorship (financial support) from the International Fund to attend the next General Meeting. Applications for sponsorship to attend the next General Meeting are based on need and are to be made to the chair of the appropriate Liaison Committee with accompanying rationale. The chair then submits the applications to the Assistant Secretary for International Initiatives, Prof. William Loader, for approval.
  - Guests from the regions named above may also under certain circumstances be eligible for sponsorship. Such guests must be nominated by members (or the Liaison Committees) and are subject to the same procedure for acquiring an invitation that applies to other quests (see above). If an invitation is extended, the guest may apply for sponsorship in the manner outlined in the previous paragraph. The Society normally sponsors up to twelve scholars per year. Application for funding should be made by the 1st December if possible. Requests received by this date will hopefully allow applicants to book cheaper flights and to deal with possible visa issues in a timely manner.

Dear Colleagues,

At the end of the First Business Meeting at the General Meeting of the SNTS in Montreal in August I shared with those present some reflections arising from the year during which I had the honour of serving as President, and from subsequent conversations with the Officers and in the Committee. My hope was to provoke conversations regarding some aspects of where we are as a Society and how we see ourselves in the future. I was grateful that members did take up the invitation, and for the feedback I and other members of the Committee, including the current President, Professor Carl Holladay, received. We have begun to consider some of the feedback, and we hope that by sending my reflections to the whole membership, others may be ready to join in the conversation.

One of the important tasks done by members of the Society present at the General Meeting is to consider the names of those who, under our rules, are proposed for membership by current members. While we may view that as a decision whether they meet our expectations for membership, we should ask ourselves, 'Why should anyone wish to become a member of SNTS?' That is a pertinent question now because our overall membership is dropping: the numbers of 'losses', by death or resignation, have for the last four years exceeded the numbers of new members. We may decide that that is of no significance: we are not a commercial enterprise and are under no compulsion to grow; indeed, we may not wish to do so. It may be that the changing profile of our numbers reflects the pattern of the discipline, or is a response to the increasing number of possibilities — conferences, societies, organisations — between which most of us must make some choices. Even so, we may want to ask ourselves, 'what is it that makes SNTS different?' 'Are we living up to our aspiration to be <u>the</u> international professional society for our field?' In what follows I focus on four issues.

1. How the Society develops, and whether it remains attractive and useful, is up to those — you — who are members. It is the members who are advocates of the Society, and who have the opportunity to propose new members. Do you find yourself suggesting that junior colleagues, whether in your institution or those you have supervised, consider membership; do you encourage and mentor them to fulfil the expectations, and then nominate them? We are addressing the wording of the web-page to try to make it more inviting to potential new members. We may also need to find ways of helping those who would like to apply for membership but who do not have 'sponsors', to find them. The majority feeling seems to be that we want to continue with our high expectations of members, but not that we want to be seen as actively exclusive.

2. A particular concern that some (not all!) share with me, is the gender balance of the Society. Our discipline is one into which historically it has been difficult for women to enter and then progress: in many places that is changing. How far should SNTS take the lead and model good practice in the support and encouragement of women scholars, alongside other under-represented groups? The percentage of women members is lower than that of women in Departments of Theology and/ or Religion in a number of our

well-represented countries, and the percentage of proposals for new members who are women continues to be low. Why is this? The question I asked earlier has in fact been put to me by a woman scholar, 'Why would I want to be a member of SNTS?' reflecting her sense of the reputation of the Society — and other Society members have told me of similar conversations with women scholars.

In fact the number, and percentage, of women participants at the Meeting in Montreal was the largest ever. With the support of the Local Organising Committee, I hosted a lunch for women participants; this offered an opportunity for networking, and support for those who had not previously attended, and it was much appreciated and enjoyed — and the hope was expressed that it could be repeated next year. Yet it remained the case, as it has been in recent years, that the number of women participating in Seminars as convenors, giving papers, or responding to them was relatively low; curiously, more of the women who were giving or responding to papers were guests than members. A number of Seminars had no women in the named 'line-up'. This can sometimes colour the perception we offer of ourselves, and the experience of those who do, or choose not to, join a Seminar.

3. The Seminars also play a significant role when members are deciding whether or not to attend the General Meeting, as well as representing to potential members the sort of things in which the Society is interested. I have heard, as perhaps many of you have done (or felt), various comments about the Society's offerings, such as, 'That is not what I do'; 'These do not reflect the areas I find most stimulating'. I am aware that this may be one aspect of the Society that is most debated: what sort of approaches do we, or do we not, want to sponsor? Do we need to be more pro-active in encouraging members to propose seminars, especially in areas not currently covered? Do we need to monitor under-supply and over-supply?

4. Subsequent conversations extended the debate about the nature of our Meetings, and why members choose to attend or not to attend. We shall in due course be trying to survey the membership to get more feedback on this — what would encourage you to attend, what discourages you, and have you stopped coming? Please do feel free to start giving feedback on this, whether regarding the academic programme, or social and organisational matters.

Membership of the Studiorum Novi Testamenti Societas is more than attendance at the General Meetings and more than free on-line access to <u>New Testament Studies</u>, although it is these and we hope you see these as benefits in return for your membership fees. (We are aware of the difficulties some members have had in renewing their membership on-line and we are working with Cambridge University Press to improve the system, but we realize more may need to be done). As a Society we have committed to supporting New Testament scholarship internationally through the work co-ordinated by the Secretary for International Initiatives. Membership is a privilege, and also a commitment.

This brings me back to me initial question, 'Why should anyone want to be a member of SNTS?'
