MINUTES of the 72nd General Meeting of the Society held at the University of Pretoria, South Africa, during 8th – 11th August, 2017

TUESDAY 8th AUGUST, 2017

17.00 BUSINESS MEETING I

The FIRST BUSINESS MEETING was held at 17.00, on Tuesday 8th August, 2017, in the Sanlam Auditorium.

Prior to the start of the First Business Meeting, Prof. Gert Steyn extended a welcome to conference participants, offered reflections upon contemporary South Africa, and stated the importance of the 72ND General Meeting of SNTS being held at the University and in the country. Then, the Dean of the Faculty of Theology, University of Pretoria, Prof. Johann Buitendag, offered a welcome to attendees on behalf of the University and Theology Faculty, the oldest such faculty in South Africa (in its 100TH year of existence).

BM2017/03 Approval of the Minutes of the General Meeting in Montreal, Canada, 2016

BM2017/04 Matters Arising from the Minutes

BM2017/05 Arrangements for the 2017 General Meeting

- Prof. Gert Stein (Chair of the LOC) made various announcements regarding the Meeting, touching upon a number of necessary details and noting that there were 134 conference meeting participants (members and their guests) and 34 accompanying persons.

BM2017/06 Election of *President* for the 73rd General Meeting in Athens, Greece (2018)

- Last year the Committee nominated Prof. Jean Zumstein (Switzerland) to be the *President* of the Society at its 73rd General Meeting of the Society in Athens, Greece. The Society elected him to serve in this role by way of applause.
- Until the Athens General Meeting, he will serve on the Committee as *President-Elect*

BM2017/07 Nomination of *President* for the 74th General Meeting in Marburg, Germany (2019)

- The Committee nominated Prof. John Kloppenborg (Canada) to be *President* of the Society at its 74th General Meeting in Marburg, Germany. The Society will vote on this nomination at the General Meeting in Athens (2018). As the nominee of the Committee, Prof. Kloppenborg now becomes the *Presidential Nominee* for 2019
- Prof. Judith Lieu (*Past President*) was warmly thanked for her service to the Society over the past 4 years, not least for her energetic, visionary, and resourceful leadership.

BM2017/08 Nomination of New Members

The *Assistant Secretary*, Prof. Todd Still, reported that the Committee approved 38 nominations of new members for consideration. He announced these names (and their countries), and confirmed that this list of names would be displayed on the Conference notice board in the Graduate Center Foyer. Members were asked to pass any comments on these nominations to the *Assistant Secretary* or other Committee members before the Second Committee Meeting on Friday. The *President* thanked Prof. Still for his service to the Society.

BM2017/09 International Initiatives

- The *Assistant Secretary for International Initiatives*, Prof. Bill Loader, spoke to his circulated report covering the year to June 2017. Prof. Loader impressed upon the Society the strategic importance of its various international initiatives and stressed the

need for the Society's ongoing sponsorship of the same. He was thanked by the *President* for his work.

BM2017/10 Treasurer's Report

- The *Treasurer*, Dr Kathy Ehrensperger, spoke regarding her circulated report and draft of the Statement of Financials Activities of the Society Accounts for the Year Ended 31st May, 2017. Whereas last year's financial report showed a deficit, this year's financials showed a small surplus. Next year's report, the *Treasurer* indicated, will show a significant expenses arising from the Montreal meeting. The *President* thanked her for her work over the course of the past year. Given that the *Treasurer* will not stand for another term, members residing in the United Kingdom who might be interested serving in this role, were encouraged to contact the *President* or *Secretary*.

BM2017/11 Any Other Business

- President's Matters—Last year, it was noted, Past-President Lieu challenged the Society to be thoughtful and intentional about its identity and purpose. The *President* thanked the Society for taking her charge seriously and reported progress along the following lines:
 1. Membership renewal through CUP;
 2. the SNTS website, made possible through the efforts of the *Secretary*;
 3. Members survey, a comprehensive, responsive, electronic survey was conducted in April-June 2017 among the membership. 751 members with email addresses were contacted, and 307 responded—a 40.9% response rate. The *President* then offered an overview of various demographics discovered by the survey and also noted a number of general, recurring themes found in the survey. Next, Prof. Holladay identified certain challenges facing the Society, not least its present profile. Additionally, ongoing concerns regarding the annual meeting and its diversity, vitality, and limitations were noted.
 4. Where do we go responding to the survey? A Working Committee will be formed to offer constructive, concrete outcomes arising from the survey.
 5. Concluding encouragement: a. Actively participate in shaping the future of the Society; b. Exercise initiative, take new initiatives, and make recommendations as members of the Society; c. Renew membership annually, and encourage our colleagues to do the same; and d. Nominate new members. The size of active members is considerably smaller than the membership roster—at least one-half smaller, perhaps two-thirds.
 6. In concluding, the *President* thanked the *Secretary*, *Assistant Secretary*, *Assistant Secretary for International Initiatives*, *Treasurer*, *Past-President*, *President-Elect*, Local Organizing Committees, and all of its members. SNTS is a non-profit organization in the best sense of the word, he noted. Its mission continues to animate and propel it.

BM2017/14 Editors' Reports

- Prof. Francis Watson (*Secretary to the Board and Journal Editor*) presented a report to the Society regarding the journal, which included names of new editorial board members endorsed by the Society: Jostein Ådna, Paul Foster, Sandra Huebenthal, Peter Oakes, Markus Oehler, Uta Poplutz, Joan Taylor, and Oda Wischmeyer.
- Prof. Paul Trebilco (*General Editor of the Monograph Series*) spoke to his distributed report. The *President* noted that Prof. Trebilco was set to retire from his office as *General Editor* of the Monograph Series at the end of 2017, and that last year the Society had elected Prof. Eddie Adams (UK) to succeed him from 2018, for 5 years
- *Editor of the Journal*: Prof. Watson is due to retire as *Editor of the Journal* on 31st December, 2018. Article C.2 of the Constitution states: 'The [Editorial] Board shall nominate, and the Society in General Meeting shall appoint, an Editor of the journal (who shall be Secretary of the Board).'

- The Editorial Board's nomination of Dr Simon Gathercole of the University of Cambridge was presented to the Members for their approval by way of applause. His election was to be ratified by the Syndics of the University Press.
- The *President* thanked Profs Trebilco, Watson, and the Editorial Board for their service to the Society.
