# SNTS NEWSLETTER

## Marburg 2019

The 74<sup>th</sup> General Meeting of the Society took place at the Philipps Universität Marburg, Germany (30 July – 2 August). About 263 academic delegates attended. The Society is grateful to Profs Lukas Bormann and Angela Standhartinger and their colleagues for collaborating to ensure the success of the meeting.

Prof. John Kloppenborg (Canada) was inducted as *President* of the Society and delivered his Presidential Address entitled, 'Social Networks in Early Christianity'.

Prof. Margaret Mitchell (USA) was elected *President* for the 2020 General Meeting in Rome, Italy. She now serves on the Committee as *President-Elect*.

Prof. John Barclay (UK) was announced as the Committee's nominee to become *President* of the Society at the 2021 General Meeting in Melbourne, Australia. His nomination will be presented at the 2020 General Meeting.

Main papers were delivered by Profs Martin de Boer (Netherlands), 'Expulsion from the Synagogue: J.L. Martyn's *History and Theology in the Fourth Gospel* Revisited'; Alain Gignac (Canada), 'Lorsque le katechon permet de repenser le politique. Discussion critique d'une thèse de Giorgio Agamben en regard de la discursivité de 2 Th 2,1-12'; Laura Nasrallah (USA), 'A theology of *defixiones*? Roman Corinth, the Sanctuary of Demeter and Kore, and Christ-followers'; and Thomas Schmeller (Germany), '*Dissimulatio artis*? Paulus und die antike Rhetorik'.

A Presidential Plenary Panel Discussion explored the subject, 'Bultmann and Demythologizing – Then and Now', and included the following contributions: Lukas Bormann (Germany), 'Bultmann's "Mythology and New Testament" (1941) in Context' / 'Bultmanns Entmythologisierungprogramm im Kontext des Jahres 1941'; Stephen Patterson (USA), 'Demythologizing in America'; and Angela Standhartinger (Germany), 'The Legacy of Bultmann's Demythologizing'.

Profs Uta Poplutz (Germany) and Risto Uro (Finland) retired from the Committee. Profs Sandra Huebenthal (Germany) and Heike Omerzu (Denmark) were elected to replace them and serve on the Committee for a period of three years. In addition, Prof. Gosnell Yorke (Zambia) was elected to serve on the Committee until the end of the General Meeting in 2021.

The *Assistant Secretary for International Initiatives*, Prof. Bill Loader (Australia), reported on the work of the four Liaison Committees (Eastern European; African; Asia/Pacific; Latin America/Caribbean). The Society's international initiatives include promoting New Testament scholarship in areas beyond those where such research has traditionally been well represented within the Society, and to identify potential new members. One innovation at this General Meeting was for 9 members and guests from Nigeria, Ghana, Lesoto, India, the Czech republic, Bulgaria, Serbia and Romania to display research posters.

The *Treasurer*, Prof. Paul Foster (UK), presented the statement of accounts.

The *Editor of New Testament Studies*, Dr Simon Gathercole (UK), reported that 111 articles had been submitted to the Journal over the past year. 20 of these had been accepted for publication. ## Rome 2020

The Society will meet next year at the Pontificia Università Urbaniana, Rome, Italy, from 28-31 July, with optional excursions on 1 August.

The *Local Organising Committee* is led by Prof. Bernardo Estrada. Further details will be included in the February-March Newsletter.

*Main Papers:* the Presidential Address will be delivered by Prof. Margaret Mitchell (USA), and Main Papers by Profs Bernadette Brooten (USA), Jean-Bosco Matand Bulembat (Congo), Christos Karakolis (Greece) and Lutz Doering (Germany).

*Seminars:* there will be 18 seminars, including one new seminar (listed below). The seminar programme will be finalised in February 2020, and published in the February-March Newsletter. Conveners of seminars are reminded that this programme has to be submitted to the *Secretary* by the beginning of February, 2020. Members who would like to present a paper in one of the seminars should contact the appropriate conveners.

*Offered Short Papers:* there will be 18 slots for Short Papers. Members wishing to offer a Short Paper of 25 minutes should send a proposal to the *Secretary*. Short Papers may be offered in English, German or French. Proposals received before 1<sup>st</sup> February will receive preference. The proposal should be accompanied by a short abstract or outline. New members are especially encouraged to take advantage of this opportunity to present their research.

*Please note that members may deliver only one paper (of any kind) at a General Meeting.*

*Nomination of Guests:* members may now invite up to **two** guests and are strongly encouraged to keep the Society's commitment to diversity in mind when doing so. Those wishing to nominate a scholar to be a guest at this General Meeting should submit the name to the *Assistant Secretary*, Prof. Todd Still. The invitation will come formally from the *President*. **An individual may now be invited up to three times in any five year period;** although, candidates for membership of the Society may not attend a General Meeting while they are being nominated for membership of the Society. (In order to avoid embarrassment, members should ensure that their annual subscription is paid before proposing a guest invitation.) Guests are of two kinds:

1. *Personal guests* (as distinct from 'accompanying persons' such as partners or children). Any member attending a General Meeting may nominate up to two non-members to be invited to attend as a personal guest. These guests may participate fully in the academic programme, although not as a presenter. Members should indicate briefly to the *Assistant Secretary* how their guest would contribute to the proceedings. It is recommended that requests be submitted by 1<sup>st</sup> April, although later requests may be considered if there is additional capacity. These guests will be asked to pay an additional registration charge of ca. €15 in lieu of Membership subscriptions.
2. *Seminar guests.* Seminars may make application through the *Assistant Secretary* to extend an invitation to a seminar guest whose expertise is germane to the work of the seminar. Such guests can be invited for one, two, or three consecutive years, and not necessarily to present a paper each year.

Only one guest may present a paper, but there is no restriction on guest respondents or guest participants. Thus a seminar might have multiple guests at a seminar, but only one guest presenter. Seminar conveners should provide a clear and strong rationale for the invitation, including the expertise that the seminar guest has to offer, and the intended outcomes of the seminar. Requests to invite a seminar guest must be received by the *Assistant Secretary* by 1<sup>st</sup> February.

*Financial Support for Members and Guests at the Rome General Meeting:* members from the regions of the Society's international initiatives (Eastern Europe, Africa, Asia/Pacific and Latin America/Caribbean) may be eligible for sponsorship (financial support) from the International Fund to attend the General Meeting. Applications for sponsorship to attend are based on need and are to be submitted to the chair of the appropriate Liaison Committee with an accompanying rationale which makes the case for sponsorship. The chair then submits the applications to the *Assistant Secretary for International Initiatives*, Prof. Bill Loader, for approval.

Guests from these regions may also be eligible for sponsorship. Members (or the Liaison Committees) may request guest invitations, following the procedure detailed above. If an invitation is offered, the guest may then apply for sponsorship.

The Society normally sponsors up to twelve scholars per year. Applications for funding should be submitted by 1<sup>st</sup> February if possible. Requests received by this date should allow

applicants to book cheaper flights and deal with possible visa issues in a timely manner.

Additionally, the Society is making it possible for members and guests from regions covered by its International Initiatives Programme to present research posters highlighting their own research and research in their particular region. This is open to all who are not otherwise presenting or responding to papers and is offered both as a way of their possibly eliciting funding and as an opportunity to help Society members appreciate the research being undertaken in their regions. The regions covered by the Liaison Committees of the International Initiatives Program are: Africa, Latin America and the Caribbean, Asia-Pacific, and Eastern Europe. Further details are available from Prof. Bill Loader, and applications should be submitted by 1<sup>st</sup> April.

## Nomination of New Members

Members are warmly encouraged to nominate new candidates for membership of the Society. *The nomination of younger scholars (including colleagues or former students) and those of diverse backgrounds is especially encouraged.*

The document 'Nominations Application (2020)' (available on the Society website) outlines both the criteria and procedure for nominating members. Nominations do need to be accompanied by a statement which makes a clear and detailed case for membership. All nominations must be received by 1<sup>st</sup> March. (Nominations will only be considered where both proposers have paid their annual subscription.) Those wishing to nominate scholars may first contact the *Assistant Secretary*, Prof. Todd Still.

## The Shape and Future of the Society

Following extensive review, feedback and discussion over the last three years, the Committee is implementing a number of changes to its practices. Some of these are already reflected in this Newsletter.

From the Rome 2020 General Meeting, the frequency of an individual attending as a personal guest is being increased to three times within a five-year period, which can be repeated. This will be reviewed by the Committee at regular intervals to ensure that it continues both to widen access, but still incentivise nominations for membership. Additionally, members will be allowed to invite up to two guests and are strongly encouraged to keep the Society's commitment to diversity in mind when doing so.

From the Melbourne 2021 General Meeting, there will be 6 Main Papers, instead of 4. It is intended that this will broaden the range of contributors to the Academic Programme.

The Committee will also prepare a resolution regarding Associate Membership for the membership to consider at its meeting in Rome.

## Important Information regarding your Personal Details

Many members will be aware that General Data Protection Regulations now apply across the European Union, and therefore to the *Studiorum Novi Testamenti Societas*.

Early in 2020, the *Secretary* will send members an email asking them to complete a short online form. This will confirm the limited personal data that the Society needs to hold (title, name, academic institution, email address) and give explicit consent for the Society to use this data, but only for its own approved purposes. (This process has been successfully completed by all 57 scholars recently elected members.)

Members will also confirm their commitment to pay annual subscriptions (until their 85<sup>th</sup> year) and to inform the *Secretary* of any changes to their personal details.

**The Society, for its part, will commit to delete those members' email addresses where they either (1) do not pay their subscriptions for two consecutive years (unless they are Life Members), or (2) do not complete the online form, by which they grant the Society permission to hold and use their contact details.**

*It follows that, without a member's explicit consent to keep and use their email address, the Society will not be able to send these bi-annual Newsletters, and CUP Membership Services will be informed that the individual has, by default, resigned their membership.*

If this deemed resignation is in error or by oversight, it will be possible for an individual's membership to be reinstated by contacting the *Secretary* (who will still hold details of the former member's name, but not their email address.)

This process is intended to protect each member's data and the Society. If members have any questions about this process, they are invited to email the *Secretary* for clarification, assistance and reassurance.
